The village Christmas tree was again successful and lit the village over the festive period. Many thanks the Cllr Higgins for providing us with a new star. The village summer event was again well attended, and the raffle and tombola raised £86 for Children in Need and £391 for our local hospice. Thanks again to Cllr Higgins for looking after the play area. Going forward for the new financial year we are again looking at ways to keep our roads safe with the possibility of purchasing a speed camera. General finances are looking okay.
